Magnolia Hunting Supply products for purchase that may be restricted in certain areas by Federal, State, and local law. Magnolia Hunting Supply is an authorized dealer of all the products it sells, but we cannot grant the right or authority to customers to purchase items which may be regulated by such laws. Products in the restricted areas will not be shipped. Magnolia Hunting Supply does not sell or ship products outside the United States.

Federal law requires that you must be 18 years old to purchase shotgun ammunition and 21 years or older to purchase handgun and rifle ammunition.

- We ship ammunition to your door via UPS ground.
- Ammunition and firearms Must Be purchased separately.
- For safety reasons, we Do Not accept returns on ammunition.
- Always make sure you use the correct ammunition for your firearms.
- Check your local laws for any other regulations Before ordering.

Firearms Restrictions

You Must be 18 or older to purchase Long Guns and 21 years or older to purchase Hand Guns. Check you r Local and State Laws.

Maryland	Firearms sales only to Class 01 FFL Dealer. Varying restrictions on Assault Weapons
Massachusetts	No Handguns, Varying restrictions on Assault Weapons
New Jersey	Firearms sales only to Class 01 FFL Dealer. Varying restrictions on Assault Weapons
New York	No Assault Weapons, No Handguns (NYC)
Washington D.C.	No Firearms
